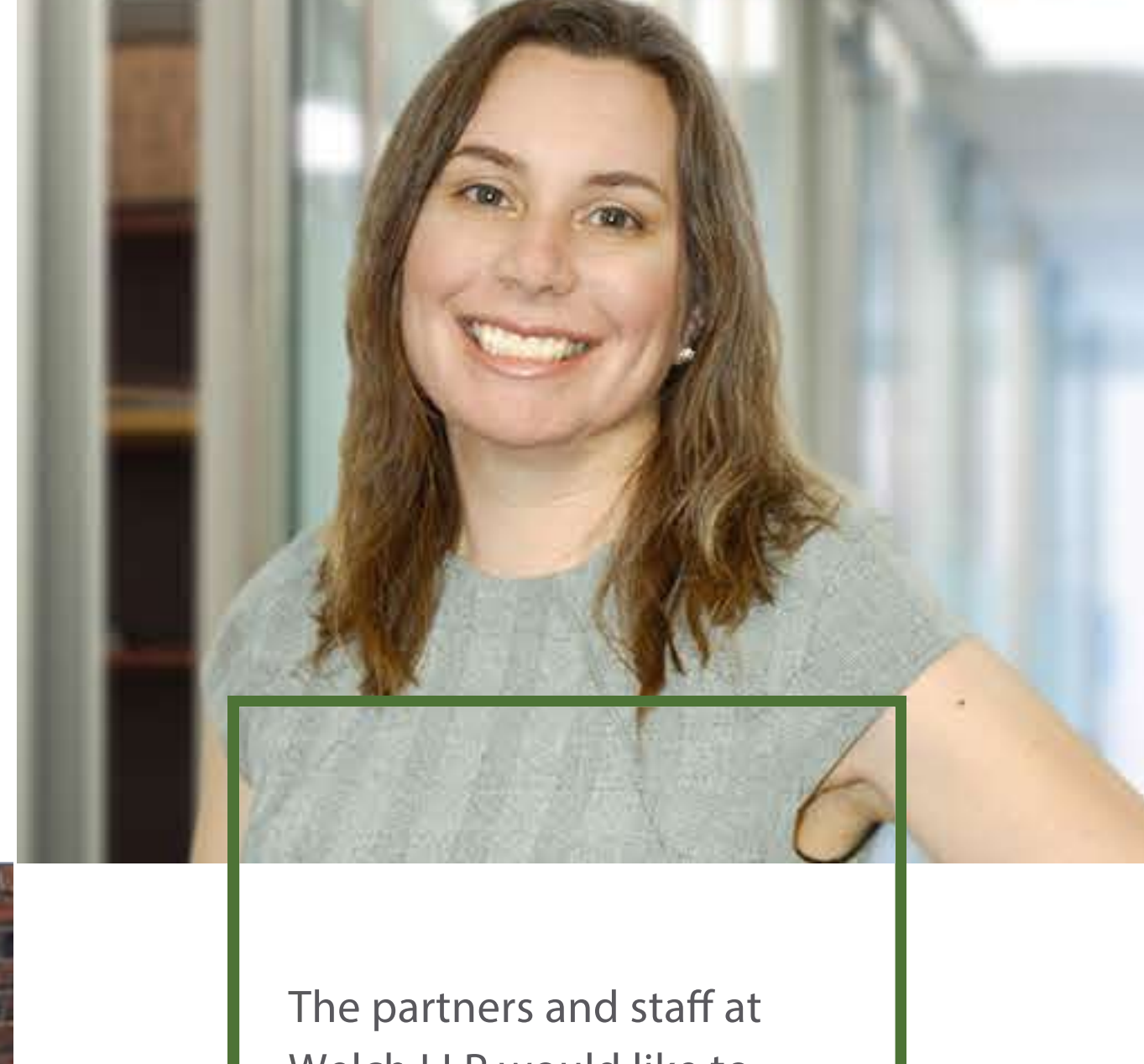


Welch LLP hosted the 2nd Annual Grand Casino in support of the ORCF on November 8th at the Shaw Centre.

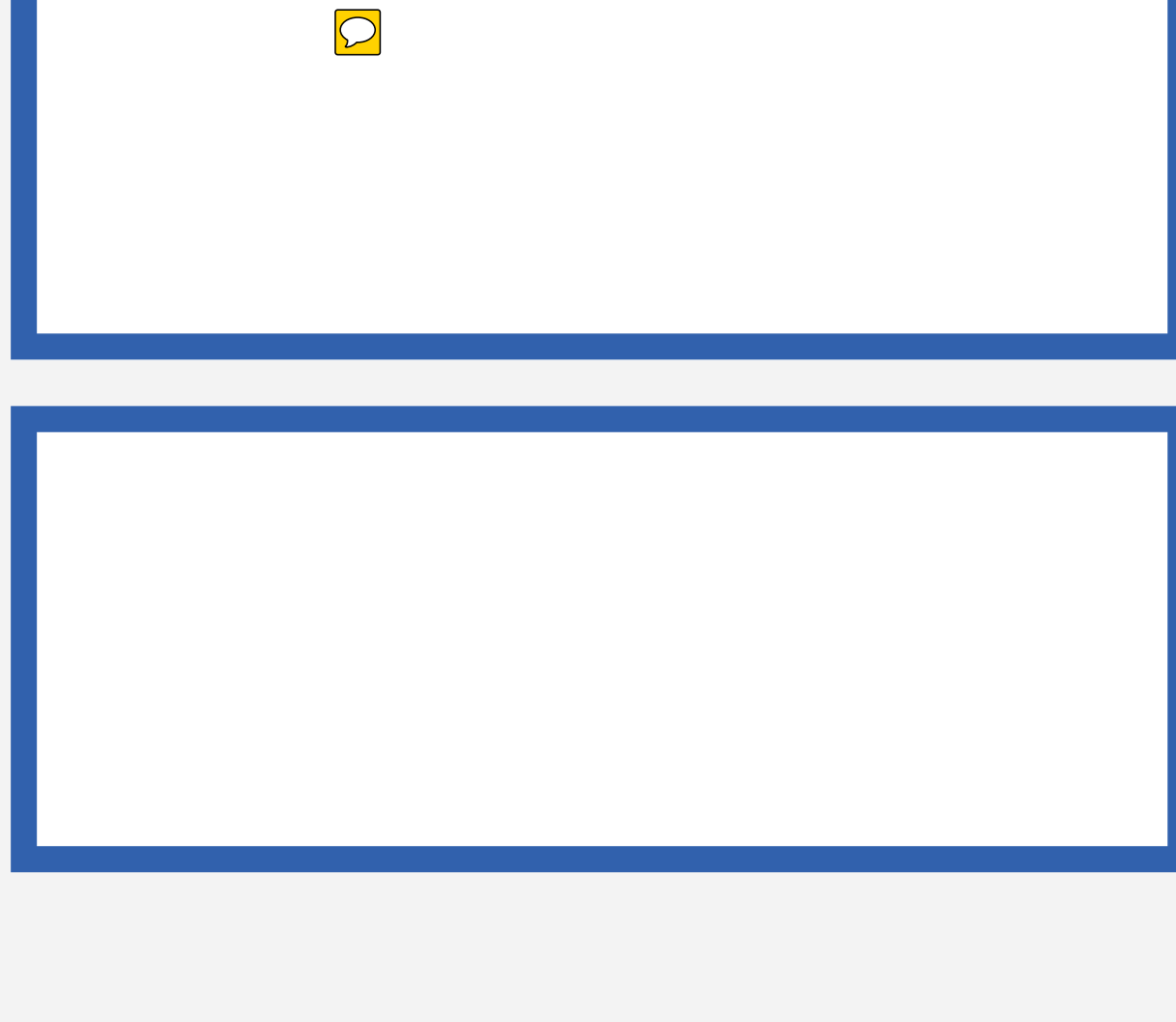
